MEETING INTRODUCTIONS

- The meeting began an overview of the meeting agenda by Dale Schafer
- GSA eligible agency meeting representatives introduced themselves

JOINT POWERS AUTHORITY STATUS

- The JPA went live on July 15th as prescribed in the document
- Three members have resolved to join (Inyo County, San Bernardino County and Indian Wells Valley Water District)
- Since the JPA is now up and running, all meetings need to be under Brown Act requirements and the JPA can not have a majority of JPA Board Members present without complying with the Brown Act
- IWVWD and Inyo have yet not appointed Board members –
- San Bernardino County appointed Supervisor Robert Lovingood as the JPA primary director and Bob Page as the alternate -

UPDATE ON BOARD HEARINGS ON JPA

- San Bernardino County
 - There was a 3-minute presentation from Gresham Savage, Counsel for Meadow Brook Dairy
 - Board of Supervisors did not discuss or request any further info, just approved the resolution to adopt the JPA on consent
- Indian Wells Valley Water District
 - o JPA resolution was approved 3-2
 - There was a similar 3-minute presentation from Gresham Savage for Meadow Brook Dairy
 - Donna Thomas with the Eastern Kern County RCD gave comments regarding urging IWVWD board to consider EKCRCD have a representation on the GSA Board – addressed by IWVWD counsel as saying late in game to add a Board member - SWRCB sent ECKRCD a letter dated June 22nd saying EKCRCD is GSA-eligible and offers a non-binding decision
 - There was also an issue brought up regarding the Doctrine of Incompatible
 Offices, which is when a public official holds two public offices SGMA
 legislation sets up to the GSA to have GSA eligible agencies on the board –
 Incompatible Offices separate and SGMA would override with specific
 legislation
 - Also brought up GSA-Eligible Agency March Summary Meeting Notes. It was noted that language had changed from being specific as to committee membership to generic
 - Irrespective of vote to join JPA, all IWVWD directors would like to see as much participation by stakeholders as possible
- Kern County
 - Kern previously determined that EKCRCD is not eligible because they are not
 elected but appointed by Kern County- since not elected not accountable –
 also have no funding .The State Water Resources Control Board offered a
 non-binding, advisory opinion. However, the JPA Board will make the
 determination whether or not the EKCRCD should be on the Board.

City

 EKCRCD also has no policing authority – regarding ECKRCD joining JPA, JPA Board will have to make formal decision in the near future

City

Resolution to join JPA will be on agenda for August 3rd City Council meeting – delayed due to absence of a Council member –

Kern County

 Resolution to join JPA on calendar for July 19th – Mojave Pistachio optimistic about working with GSA

• IWVWD

- Does not think mutual water companies are trying to push their way onto JPA Board – MWC's want assurances of meaningful participation on committees and don't see that as the documents stand now
- If JPA board moves forward without more assurances for meaningful participation, they may consider litigation

Facilitator

 Meadow Brook Dairy has said they want meaningful participation – need to start thinking about what the advisory committee(s) would do and who would be on it

City

o JPA will have to take up bylaws and other things before committees

Kern County

 Gresham has it in writing that they will have meaningful participation – will be in bylaws

Citv

 Need to set expectations – will have a lot to do – so won't be the first task accomplished

Kern County

o Kern BoS could provide direction to staff to work on committees –

 Perhaps form an Adhoc committee to discuss meaningful participation and Committee composition?

Kern County

- Interested in demonstrating and showing how it will work and what meaningful participation looks like
- Need fair representation from all aspects of our community showing specific value of community, how the committee will be formed, and their charge
- Committees have to have structure and have information flow back and forth
 locals can help us construct

Kern Legal

 92 court cases purport to define term "meaningful participation" – depends on circumstances – "An opportunity to present one views and for fairness"
