The meeting is called to order by Chairwoman Breeden at 10:00 a.m.

5. PUBLIC COMMENTS:

Judie Decker, representing the Eastern Kern County Resource Conservation District (EKCRCD), reports that a new California Irrigation Management Information System (CIMIS) station has been installed on the golf course of the China Lake Base. Ms. Decker thanks the Navy for their help with the project.

Shirley Kirkpatrick voices her concerns regarding Los Angeles Department of Water and Power (LADWP) taking water from the Owens Valley that historically flowed to the Indian Wells Valley (IWV) basin and the possibility of LADWP building a water desalination plant.

Nick Panzer comments that he believes the reduction in pumping is necessary to achieve sustainability and should first go to the health and safety of all users in the IWV and Searles Valley. Comment letter submitted.

West Katzenstein seconds the key elements of Nick Panzer's comments.

Ralph Lachenmaier voices his concerns regarding the value of his house decreasing and the Board not following up on multiple options other than importing water.

Chairwoman Breeden requests agenda item #6c be pulled for further discussion.

Motion made by Mick Gleason and seconded by Luther Snoke to approve the Minutes of Board Meeting September 20, 2018, Expenditures in the amount of \$279.07 to RWG Law, \$68,905.43 to Stetson Engineers, and Resolution 04-18. Motion carried unanimously. (Ayes: Breeden, Brown, Gleason, Harrington, Snoke. Nays: None. Absent: None.)

General Manager Ron Strand provides the financial report update.

Motion made by Peter Brown and seconded by Bob Harrington to approve the agenda item #6c – Financial Report. Motion carried unanimously. (Ayes: Breeden, Brown, Gleason, Harrington, Snoke. Nays: None. Absent: None.)

7. WATER REOURCES MANAGER REPORT:

a. Report/Discussion on Plan of Action and Milestones (POAM)

Jeff Helsley provides a report on the updated POAM. (Available at www.IWVGA.org)

b. Report on Submittal of Proposition 1 Grant Application Status:

Steve Johnson provides an update on the Proposition 1 Grant status. Progress Reports/Invoices are required to be submitted quarterly to Department of Water Resources (DWR). The goal is to have the first Progress Report/Invoice submitted by November or December 2018. Staff recommends that the IWVGA Board hire an Administrative Analyst to reduce costs accrued by Stetson Engineers.

c. Report on Pump fee Status/Schedule:

Mr. Johnson provides an update on the Pump Fee Status. A total of 44 wells have registered, leaving 29 un-registered. Those 29 un-registered wells are believed to be non-de-minimis based

on criteria. October pumping reports and payments are due by November 10th. Total pumping reported thus far is 2,242 acre-feet (AF).

d. Update on Oct 1,2018 WRM/Markman Pumping Allocation Meetings:

Mr. Johnson provides an update on the Pumping Allocation meetings.

Steve Johnson and Jim Markman, Special Counsel, met with five (5) pumping groups including: Navy, municipal (including mutual), industrial (including Searles Valley Minerals), large and small agriculture, and domestic/de-minimis wells. Notes were prepared by Mr. Johnson from each group meeting and will be provided to IWVGA Board staff prior to being provided to Board members.

Jim Markman plans to attend the next IWVGA Board meeting and provide a report. It is unsure at this time if the report will be presented during closed or open session.

Key points mentioned at the Pumping Allocation meeting included:

- ➤ Health and Safety water allocation
- > Imported Water
- ➤ Reduced pumping by all users
- Any "ramp down" of pumping must be fair and equitable.

Mr. Johnson also mentions the technical concerns discussed at the Pumping Allocation meetings.

The Board hears comments from Nick Panzer, Will Liebscher, Tom Mulvihill, Judie Decker, Derek Hoffman, and Ralph Lachenmaier.

8. RESOLUTION 05-18 - APPROVAL OF AN AGREEMENT FOR BROWN ARMSTRONG TO CONDUCT A FINANCIAL AUDIT OF AUTHORITY:

Ron Strand provides a brief description of Resolution No. 05-18. The IWVGA is required to conduct an audit certified by a public accountant. The audit is due by December 31, 2018. Kern County serves as the fiscal treasurer agent for the IWVGA and recommended Brown Armstrong as a suitable accountant to conduct the audit. Staff recommends the Board approve the Agreement so staff may proceed.

Motion made by Mick Gleason and seconded by Peter Brown to approve Resolution No. 05-18, Approval of an Agreement for Brown Armstrong to conduct a financial audit of Authority. Motion carried unanimously. (Ayes: Breeden, Brown, Gleason, Harrington, Snoke. Nays: None. Absent: None.)

11. GENERAL MANAGER'S REPORT:

Keith Lemieux reports that the Association of California Water Agencies Joint Powers Insurance Authority (ACWA-JPIA) is considering establishing a new limited purpose risk pool. The risk pool would provide coverage for actions taken while a Groundwater Sustainability Plan (GSP) is being validated. A certain critical mass would need to be reached in order for there to be enough money to fund the risk pool, so there have been discussions of a preliminary buy-in of \$10,000. The Board directs staff to bring further information back at the next Regular Board meeting.

Mr. Lemieux provides a report from Closed Session which took place at the beginning of this meeting; stating that no action was taken which would require disclosure under the Brown Act. Discussions were concluded with respect to those matters and no further Closed Session is needed today.

SUBJECT: Approval of General Liability Insurance Coverages for IWVGA

DISCUSSION

The staff of the IWVGA has explored purchasing general liability and other related insurance to cover the organization in case of loss. The IWVGA is now functioning as a public agency that is subject to certain kinds of general liability claims. Without insurance, the IWVGA would not be able to pay such claims.

Staff made contact with public agency pools and insurance brokers to gain quotes for insurance coverages. Two entities responded to staff requests for insurance quotes: JPRIMA and Glatfelter Public Practice. Both offered the coverages we requested; however, JPRIMA provided the least expensive quote of \$8,654 annually for all coverages. The Glatfelter quote was \$15,344 annually. The premiums and categories of coverage are summarized in the attached spreadsheet.

The proposals submitted provide the necessary coverage for the IWVGA, but there is a difference in the nature of the coverage. Glatfelter provided a traditional insurance quote. Glatfelter is an insurance company that is providing a policy of coverage for the IWVGA as an agency based upon its assessment of risks associated with the activities of the Authority. It's pretty straightforward insurance.

JPRIMA coverage is different in that it is "pooled" coverage. JPRIMA is an association that offers to join together or pool its members in a self-insurance and insurance purchasing group. The way it works is the members share or pool their risk. Members make deposits to the pool, which are just like premiums, and then pay claims from those deposits using an insurance pool administrator that has experience in evaluation, paying, and settling claims. In return for more affordable coverage, the members also share the risk with all the other members. So if there is a high number of claims or a large claim in the pool, all the members share in the costs of those claims. Thus, it is called a pool because costs and benefits are shared or spread among a relatively large pool of members.

The pooled coverage is acceptable coverage and is typical of coverage obtained by public agencies, and it is perfectly appropriate for the Authority to consider. In fact, the agency members of the IWVGA purchase coverage from insurance or risk management pooled coverage for their basic governmental operations. So understand that the pooled policy we are considering provides the coverages the staff believes are minimal for the IWVGA.

RECOMMENDATION

Staff recommends that the IWVGA Board approve the General Liability Insurance proposal from JPRIMA for \$8,654 annually.

Institute and Reimbursement Agreement between the Indian Wells Valley Groundwater Authority and the Indian Wells Valley Water District as a

representative member of the Brackish Water Group.

DISCUSSION

At the May 17, 2018 meeting of the Indian Wells Valley Groundwater Authority ("IWVGA"), the Board of Directors voted to approve and enter into agreement with the Board of Regents of the Nevada System of Higher Education on behalf of Desert Research Institute ("DRI") to use the groundwater model developed by DRI in support of the IWVGA's work in developing and drafting a Groundwater Sustainability Plan ("GSP").

The Brackish Water Group ("BWG") has received funding from the State of California to identify and quantify groundwater resources and to evaluate the feasibility of extracting brackish groundwater as a supplemental water supply source within the Indian Wells Valley ("IWV"). One component of this study is to evaluate the impacts of extracting brackish water on the overall groundwater system within the IWV. The BWG is requesting assistance from DRI to develop a solute transport model for Total Dissolved Solids ("TDS") to simulate a suite of brackish water extraction scenarios.

DRI has provided Exhibit A, "DRI Proposal for Simulation of Water Extraction Scenarios for the Brackish Water Group," outlining nine model scenarios requested by the BWG along with the budgetary cost associated. The additional work by DRI described in Exhibit "A" will require an amendment to the Contract between the IWVGA and DRI and an increased budget estimated at \$53,000.

The BWG has agreed to reimburse the IWVGA for any additional costs associated with DRI's work described in Exhibit "A". The "Reimbursement Agreement" is to ensure the IWVGA is reimbursed for any monies paid to DRI for services undertaken on behalf of the BWG with respect to the activities described in Exhibit A and has been drafted, reviewed, and accepted by the BWG.

ACTION(S) REQUIRED BY THE BOARD

Staff is seeking and recommending Board approval of two documents.

- 1) Amendment to the Agreement Between the INDIAN WELLS VALLEY GROUNDWATER AUTHORITY and the BOARD OF REGENTS of the NEVADA SYSTEM OF HIGHER EDUCATION on behalf of the DESERT RESEARCH INSTITUTE
- 2) "Reimbursement Agreement" between the INDIAN WELLS VALLEY GROUNDWATER AUTHORITY and the INDIAN WELLS VALLEY WATER DISTRICT as a representative of the Brackish Water Group

AMENDMENT TO THE AGREEMENT BETWEEN the INDIAN WELLS VALLEY GROUNDWATER AUTHORITY

and the BOARD OF REGENTS of the NEVADA SYSTEM OF HIGHER EDUCATION on behalf of the DESERT RESEARCH INSTITUTE

Whereas, the INDIAN WELLS VALLEY GROUNDWATER AUTHORITY (hereinafter "Authority") and the BOARD OF REGENTS of the NEVADA SYSTEM OF HIGHER EDUCATION on behalf of the DESERT RESEARCH INSTITUTE (hereinafter "DRI") entered into an agreement on [DATE] ("Agreement") whereby DRI would assist the Authority in using DRI's groundwater model to support the Authority's work on its Groundwater Sustainability Plan ("GSP"). The Authority and DRI are sometimes hereinafter collectively called the "Parties."

Whereas, the Brackish Water Group ("Group") is working on a Brackish Water Resource Feasibility Study ("Study") to identify and quantify brackish groundwater resources that may be used as an alternative water supply source within the Indian Wells Valley basin.

Whereas, one component of the Study is to evaluate the impacts of extracting brackish water on the overall groundwater system with the Indian Wells Valley basin.

Whereas, the Group wishes to have DRI develop and simulate a suite of brackish water extractions using the groundwater model presently being used by DRI to assist the Authority in implementing its GSP.

Whereas, Section 3 of the Agreement specifies the consideration under the Agreement.

Whereas, Section 3(b) of the Agreement states that "If the scope of work described under this Agreement expands, [Authority] shall initiate an amendment to include added scope and funding that is mutually agreed upon by DRI and [Authority]. All work will be authorized on a Task and associated Budget basis."

Whereas, the Parties now desire to amend the Agreement to include added scope and funding.

The Parties, based upon mutual consideration, hereby agree as follows:

- 1. DRI shall develop and simulate a suite of brackish water extractions using the groundwater model presently being used by DRI to assist the Authority in implementing its GSP. DRI shall perform the duties/tasks in accordance with the DRI Scope of Work and Budget, a copy of which is attached hereto as "Exhibit A" and by reference made part of the Agreement.
- 2. The Authority's Water Resources Manager ("WRM") has the sole authority to coordinate

DRI's tasks related to its work for the Authority and the Group. The WRM shall have the authority to determine if DRI's work on behalf of the Group related to its development and simulation of the suite of brackish water extractions described in Exhibit "A" is impacting DRI's work/progress for the Authority and to make any necessary time/schedule adjustments deemed necessary by the WRM. The WRM shall consult with the Group prior to making any recommendations with respect to any time/schedule adjustments.

REIMBURSEMENT AGREEMENT

This Reimbursement Agreement (the "<u>Agreement</u>") is entered into as of November _____, 2018 ("<u>Effective Date</u>"), between the Indian Wells Valley Groundwater Authority, a Joint Powers Authority created pursuant to the provisions of California Government Code sections 6500 et seq., ("Authority") and the Indian Wells Valley Water District, a County Water District ("<u>District</u>"). The Authority and Group are sometimes hereinafter individually or collectively called a "<u>Party</u>" or the "Parties".

RECITALS

WHEREAS, the Authority was formed after enactment of the "Sustainable Groundwater Management Act" ("SGMA") for the purpose of becoming the exclusive Groundwater Sustainability Agency and achieving groundwater sustainability through the adoption and implementation of a Groundwater Sustainability Plan ("GSP") for the Indian Wells Valley basin.

WHEREAS, the Authority entered into an Agreement with the Desert Research Institute ("DRI") whereby DRI would assist the Authority in using DRI's groundwater model to support the Authority's work on its GSP.

WHEREAS, the Indian Wells Valley Water District is a member of the Brackish Water Group comprised of the District, Searles Valley Minerals Inc., CGP Holdings LLC, and Mojave Pistachios LLC, (collectively referred to herein as the "Group").

WHEREAS, the Group is working on a Brackish Water Resource Feasibility Study ("Study") to identify and quantify brackish water resources that may be used as an alternative water supply source within the Indian Wells Valley basin.

WHEREAS, one component of the Study is to evaluate the impacts of extracting brackish water on the overall groundwater system with the IWV basin.

WHEREAS, the Group wishes to have DRI develop and simulate a suite of brackish water extractions described in Exhibit "A" using the groundwater model presently being used by DRI to assist the Authority in implementing its GSP.

WHEREAS, the Authority is agreeable to DRI developing and simulating the suite of brackish water extractions described in Exhibit "A" subject to the terms and provisions of this Agreement.

NOW THEREFORE, in consideration of the foregoing Recitals, which are incorporated herein by this reference, and of the covenants and agreements herein contained, the Parties hereto agree as follows:

- 1. <u>Purpose.</u> The purpose of this Agreement is to ensure the Authority is reimbursed for any monies paid to DRI for services undertaken on behalf of the Group with respect to the activities described in Exhibit "A".
- 2. Reimbursement. The Group agrees to reimburse the Authority up to Fifty-Three Thousand Dollars (\$53,000.00) for DRI to develop and simulate a suite of brackish water extractions described in Exhibit "A" using the groundwater model presently being used by DRI to assist the Authority in implementing its GSP. The Authority shall submit a monthly invoice to the Group for any expenses incurred for DRI's providing the services described in Exhibit "A". The invoice shall include copies of all invoices/charges paid by the Authority to DRI for the services described in Exhibit "A". The Group shall remit payment within thirty (30) days receipt of said invoice.
- 3. <u>Priority.</u> The Group understands and acknowledges that DRI's work for the Authority is the highest priority, and if time adjustments need to be made, DRI's work for the Authority shall take precedent over any activities undertaken on behalf of the Group as described in Exhibit "A" and the timeline described in Exhibit "A" shall be adjusted accordingly.
- 4. <u>Coordination.</u> The Parties agree that the Authority's Water Resources Manager ("WRM") has the sole authority to coordinate DRI's tasks related to its work for the Authority and the Group. The WRM shall have the authority to determine if DRI's work on behalf of the Group related to its development and simulation of the suite of brackish water extractions described in Exhibit "A" is impacting DRI's work/progress for the Authority and to make any necessary time/schedule adjustments deemed necessary by the WRM. The WRM shall consult with the Group prior to making any recommendations with respect to any time/schedule adjustments.
- 5. <u>Dispute Resolution.</u> In the event there are disputes and/or controversies relating to the interpretation, construction, performance, termination or breach of this Agreement, the Parties shall in good faith meet and confer in an attempt to informally resolve such matter(s). If the Parties are unsuccessful in resolving such matter(s) through an informal meeting process, they may attempt to resolve such matter(s) through mediation, through arbitration under the rules and regulations of the American Arbitration Association or they may exercise whatever other legal rights and remedies they may have.
- 6. <u>Termination</u>. Either Party retains the right to terminate this Agreement, at its sole discretion, upon thirty (30) days written notice. In the event of termination of this Agreement, the payment of monies due to Authority for DRI's work performed prior to the effective date of such termination shall be paid within thirty (30) days after receipt of an invoice as provided in this Agreement. Upon payment for such services, the Authority agrees to promptly provide to the Group all documents, reports and the like which are in the possession or control of the Authority and/or DRI and pertain to the Group or this Agreement, except that Authority may retain one complete copy to be maintained in Authority's files.

Thursday, November 14th, 2018, Time 10:00 AM.

- Item 1. Call to Order of the November 1, 2018 meeting.

- Item 2. Public Comments.
 - No comments at this time.
- Item 3. WSM Discussion of Draft GSP Sections Plan Area, Basin Settings, Project and Management Actions
- -GSP Modeling Schedule and Baseline Assumptions
 - O Report of Baseline modeling with chemistry data Total Dissolved Solids (TDS)/Water Quality(WQ). DRI on the phone with quick update. Baseline model scenario and fate and transport modeling will soon begin. DRI will present preliminary results when ready. Future model ad hoc group discussions regarding pumpage and recharge i.e. wet vs. dry seasons and modeling outputs over 50 yrs and also WQ changes that may occur.
 - o Comments included recharge timing changes with reduced pumpage, possible management areas affected by seismic zones may greatly affect flow, possible model zone changes.
- -Modeling Scenarios
 - o Modeling scenarios are moving forward in December/January with all comments being considered.
 - Ocomments included addressing mitigation issues with shallow wells for both small and large private and public, differential ramp down options and model affects, water quantity and quality impacts. Allocation based pumpage and distribution concerns among groups applicable to modeling scenarios in technical matters will have to be discussed.
 - o Navy funding will become available and highly recommended it be used.
 - O Also management scenarios including establishment of minimum threshholds and measurable objectives will be part of modeling, encouragement of historical data to help with thresholds be provided, construction history and data from private owners would be very helpful. Domestic well data and impact on them, which wells are needed and proper establishment and tracking of di minimus users because eventually all users must be registered.
 - Additionally, the WRM/TAC must nominate projects to answer data gaps to the GA so a formal request can be made to the Navy for funds authorized in the 2019 National Defense Authorization Act.
- -Data Gap Ad Hoc Report
 - Location of missing data is important but after existing data is properly reviewed.
 November ad hoc call dates were set. TSS grant funds must be set before year end. Cascade Drilling is available and access agreements must be established with land owners.

Extraction of monitoring data for both static and pumping water levels including installation and monitoring data plan fees.

 capabilities with other technologies available, how they may assist gathering additional
 water level elevation data that will be used in the GSP and then report back to the TAC in
 December. The motion was seconded and approved.

PAC Report for IWVGA Board of Directors Meeting – November 15, 2018

A quorum of 10 PAC members was established at the roll call.

Approval of minutes of August 2, 2018 PAC meeting. Minutes of September 6, 2018 tabled until next PAC meeting.

No Public Comments.

Item #4 Discussion of Pumping Allocations and Comments Regarding Uses and Users. Listed below is a bullet list of some of the input from PAC members and members of the public.

- This was the first opportunity for each PAC stakeholder group to see and review the comments of each group of representatives that met with Mr. Markman and Steve Johnson on October 1, 2018.
- Good forum and good first step. The policy and science side are both developing.
- Next step might include Draft Management scenarios an opportunity for PAC to provide scenarios and allocation themes
- Summary is helpful; need more followup meetings. All options need to be equitable for all; additional discussion should include water rights issues.
- There should be more discussion of options from DACs. The two DAC proposals that are included in the Proposition 1 grant funding should be implemented as soon as possible. The Inyokern CSD, for example, needs assistance to repair a leak in a storage tank and needs a back up water tank to use while the storage tank is repaired. There was also discussion about how to address doubling of water rates (or other proposals for increased costs) for resident with low income or fixed incomes.
- Technical information is needed. Data needed regarding what is the effect of various options on domestic wells.
- Many mutuals and co-ops have not responded to letters requesting their well registration.
- All wells in the valley should be registered; we can move forward, but ultimately need data from all wells.
- Regarding discussion of uses and users that may not have been addressed in groundwater production figures – IWV brewery, well for construction water use for Granite Construction, water use for horse and burro facility (we learned that the water is provided by the Navy for the facility and would be included in the Federal Reserve Rights production numbers).
- Need to quantify how much groundwater is in storage and the quality of that water.
- Learn how adjudications and other GSAs are meeting with and working with stakeholder groups.
- Address quality of life issues. See attached copy of Water Code Section 13050 (f) list of "beneficial uses of the waters of the state".
- It will take a number of years before we know exact numbers for recharge and production and have validation data from the modeling numbers and options.

• PAC members request that we have specific direction from the GA Board as to how the PAC should proceed with allocation discussion task. We would like to have a detailed agenda for our second meeting with Mr. Markman and Water Resource Manager Mr. Johnson on December 6, 2018.

Item #5. Appointment of PAC Vice-Chair. Consensus of the PAC members is to ask David Janiec to be Vice-Chair.

Items #6 and #7 Outreach Coordination and Planning for Imported Water and for Recycled Water were discussed together.

PAC members reviewed the outline for the Communication and Engagement Plan – approved by IWVGA on April 19, 2018 and available on the IWVGA website. We recommend that the IWVGA Board members and staff reference the C&E Plan.

- It is vital to reach out to every person in the basin. Bottom of Page 4 states that "those who are affected by a decision have a right to be involved in the decision-making process."
- PAC recommends Focused workshops scheduled in a meeting venue large enough for expected attendance and held in the evening (Pages 6 and 7)
- PAC recommends that the members of the Speaker's Bureau make presentations on the topics.
- Materials on the topics should be made available to the public on the IWVGA website, with hard copies and access to electronic copies at libraries and other appropriate public places.
- Present a user's perspective focusing on general concepts such as affordability of the water; supply and demand issues; quantity available; reliability of the source; and the plan from the GA (suggestions from member of the public Stan Rajtora).

On a personal note, I have decided not to apply for re-appointment as a Director for the Eastern Kern County RCD Board. EKCRCD will designate a new Board member as its representative on the IWVGA PAC. I will continue to act as an EKCRCD Board member until the new appointee is sworn in.

- (i) "Water quality control" means the regulation of any activity or factor which may affect the quality of the waters of the state and includes the prevention and correction of water pollution and nuisance.
- (j) "Water quality control plan" consists of a designation or establishment for the waters within a specified area of all of the following:
- (1) Beneficial uses to be protected.
- (2) Water quality objectives.
- (3) A program of implementation needed for achieving water quality objectives.
- (k) "Contamination" means an impairment of the quality of the waters of the state by waste to a degree which creates a hazard to the public health through poisoning or through the spread of disease. "Contamination" includes any equivalent effect resulting from the disposal of waste, whether or not waters of the state are affected.
- (I) "Pollution" means an alteration of the quality of the waters of the state by waste to a degree which unreasonably affects either of the following:
- (A) The waters for beneficial uses.
- (B) Facilities which serve these beneficial uses.
- (2) "Pollution" may include "contamination."
- (m) "Nuisance" means anything which meets all of the following requirements:
- (1) Is injurious to health, or is indecent or offensive to the senses, or an obstruction to the free use of property, so as to interfere with the comfortable enjoyment of life or property.
- (2) Affects at the same time an entire community or neighborhood, or any considerable number of persons, although the extent of the annoyance or damage inflicted upon individuals may be unequal.
- (3) Occurs during, or as a result of, the treatment or disposal of wastes.
- (n) "Recycled water" means water which, as a result of treatment of waste, is suitable for a direct beneficial use or a controlled use that would not otherwise occur and is therefor considered a valuable resource.
- (o) "Citizen or domiciliary" of the state includes a foreign corporation having substantial business contacts in the state or which is subject to service of process in this state.
- (p) (1) "Hazardous substance" means either of the following:
- (A) For discharge to surface waters, any substance determined to be a hazardous substance pursuant to Section 311(b)(2) of the Federal Water Pollution Control Act (33 U.S.C. Sec. 1251 et seq.).
- (B) For discharge to groundwater, any substance listed as a hazardous waste or hazardous material pursuant to Section 25140 of the Health and Safety Code,

without regard to whether the substance is intended to be used, reused, or discarded, except that "hazardous substance" does not include any substance excluded from Section 311(b)(2) of the Federal Water Pollution Control Act because it is within the scope of Section 311(a)(1) of that act.

- (2) "Hazardous substance" does not include any of the following:
- (A) Nontoxic, nonflammable, and noncorrosive stormwater runoff drained from underground vaults, chambers, or manholes into gutters or storm sewers.
- (B) Any pesticide which is applied for agricultural purposes or is applied in accordance with a cooperative agreement authorized by Section 116180 of the Health and Safety Code, and is not discharged accidentally or for purposes of disposal, the application of which is in compliance with all applicable state and federal laws and regulations.
- (C) Any discharge to surface water of a quantity less than a reportable quantity as determined by regulations is sued pursuant to Section 311(b)(4) of the Federal Water Pollution Control Act.
- (D) Any discharge to land which results, or probably will result, in a discharge to groundwater if the amount of the discharge to land is less than a reportable quantity, as determined by regulations adopted pursuant to Section 13271, for substances listed as hazardous pursuant to Section 25140 of the Health and Safety Code. No discharge shall be deemed a discharge of a reportable quantity until regulations set a reportable quantity for the substance discharged.
- (q) (1) "Mining waste" means all solid, semisolid, and liquid waste materials from the extraction, beneficiation, and processing of ores and minerals. Mining waste includes, but is not limited to, soil, waste rock, and overburden, as defined in Section 2732 of the Public Resources Code, and tailings, slag, and other processed waste materials, including cementitious materials that are managed at the cement manufacturing facility where the materials were generated.
- (2) For the purposes of this subdivision, "cementitious material" means cement, cement kiln dust, clinker, and clinker dust.
- (r) "Master recycling permit" means a permit issued to a supplier or a distributor, or both, of recycled water, that includes waste discharge requirements prescribed pursuant to Section 13263 and water recycling requirements prescribed pursuant to Section 13523.1.
