Subject: Defense Communities Infrastructure Program (DCIP) – Implementation Guidelines

Letter of Support

The following memorandum will provide a status update on the DCIP Implementation Guidelines for the FY 2020 program, the proposed updates to the FY 2021 program, and the rationale behind why we are asking for a letter of support for these revisions

DCIP Background

As we have discussed in past monthly reports from this year, the DCIP is a program in the Department of Defense budget that aims to assist communities in improving infrastructure that supports the mission and communities around US military installations. A total of \$50 million was appropriated by the Congress for DCIP during FY2020. This is the first \$50 million of the total \$100 million Authorized by the Congress for DCIP under the pilot project. It is anticipated that the remaining \$50 million will be Appropriated by the Congress during the FY2021 cycle. The program is in the FY 2020 National Defense Authorization Act, but it must survive the negotiations of the Conference Committee to settle the differences between the House and Senate versions of the bill. Based upon the outcomes of the DCIP pilot project, the Congress will be required to reauthorize DCIP and determine future amounts for appropriation.

Under the current guidelines, the IWVGA imported infrastructure project will be eligible for program funding once the Board has selected a project and completed engineering and permitting. As the project is not "shovel ready" it is not eligible for funding during this currently-appropriated tranche. DOD has interpreted the single-year funding by the Congress to mean that projects must be "shovel ready" and have the ability to be completed within the fiscal year of the funding. As we expected, and previously reported to the Authority, the IWVGA project does not currently meet these criteria. IWVGA cannot seek listing and eligibility of the IWVGA Project under the proposed implementation guidelines until such time as the Authority makes a determination on the final project route and begins engineering and permitting. Once such a determination is made, the IWVGA Project is eligible for application. However, this program could be a useful one for future potential funding once the project meets the criteria, and us such, we recommend continued support of it.

Implementation Guidelines and the FY 2020 Awardees

The Office of Economic Adjustment (OEA) published final draft implementation guidelines to the Undersecretary and Secretary of Defense for final approval and publishing in April and were approved on May 8th. The project criteria that were selected skewed differently than many people anticipated because of a change in the OEA's priority of judging criteria. When the OEA released its criteria for eligible projects, it added a

"military family quality of life" component as a base criterion for award judgment. As such, the list of eligible projects deemed "finalists" skewed heavily towards educational facilities and recreation centers, and left many resiliency infrastructure projects off of the list of finalists. Please see the attached list of finalists for the DCIP program. The resiliency programs that we are referencing are in the Tier 2 "Resiliency" section and were not selected for further consideration.

When the OEA announced the 16 awardees in late September (link to the list is here), no awarded project had any relation to resiliency or hard infrastructure improvements. As such, many people felt that the "quality of life" guideline made many resiliency projects rank below community centers and education facilities, and that the guidance change deviated from the original intent of the DCIP.

Proposed Changes to the FY 2021 DCIP

In response to the concerns about the change in criteria, Rep. John Garamendi (D-CA and Chairman of the Readiness Subcommittee on House Armed Services) proposed Section 2861 to the House NDAA that specifically addresses two areas of the DCIP:

- 1) Change the priority of the DCIP selection criteria to the following order:
 - a. **First,** projects that will enhance military installation resilience
 - b. Second, projects that will enhance military value at a military installation
 - c. Third, projects that will enhance military family quality of life at a military installation
- 2) Local or State Match At the discretion of the Secretary of Defense, the Secretary may consider a local or state match below 30% if the proposed infrastructure is in a rural area and that the "proposed community infrastructure project is advantageous for reasons related to national security."

We believe that both of these proposed revisions to the DCIP could be beneficial to the IWVGA's proposed infrastructure project, and as such we are requesting your consideration of a letter of support for these changes. Currently, this language is in the House version of the NDAA but <u>not</u> in the Senate version. As such, this section is subject to negotiations during the Conference Committee. While it is highly unlikely that the Conference Committee will convene before the November election, it is possible that it will convene shortly thereafter. As such, we are requesting your consideration of this letter and support now rather than waiting for the November Board meeting.

Next Steps

Should you approve this letter, we will use this during our discussions regarding NDAA priorities to urge both the passage of this section and our proposed amendments in the final version of the NDAA. RE: Section 2861, House 6395 as passed by the House of Representatives Defense Communities Infrastructure Program

Dear Chairman Smith, Chairman Inhofe, Ranking Member Thornberry, Ranking Member Reed

The Indian Wells Valley Groundwater Authority (IWVGA) supports modification to the Defense Communities Infrastructure Program (DCIP) that will assist in achieving resiliency at our Nation's military installations. These modifications appear in Section 2861 of H.R. 6395, as passed by the House of Representatives and we urge their inclusion in the final National Defense Authorization Act for Fiscal Year 2021.

As the civilian groundwater authority serving the area that includes the Naval Air Weapons Station, China Lake in Ridgecrest, California (NAWSCL), we fully understand the importance of achieving water sustainability and resiliency at military installations. We have worked closely over the past few years with NAWSCL to develop water solutions that will positively affect the region. Water scarcity continues to be an increasing factor within our region impacting our residents, those military families living off-installation, and NAWSCL which has deemed water scarcity as an encroachment issue on its mission status.

The DCIP is critical those communities and agencies adjacent to military installations. It enhances the opportunity to create regional solutions through public-public partnerships with the Department of Defense which, in turn, enhance the quality of life for military personnel and assist in achieving sustainability or resilience on the installation. For example, IWVGA has proposed a water interconnection project that would allow for the delivery of imported water supplies to our area and potentially create water storage opportunities. The project would enhance the quality of life for military personnel living off-installation. In addition, the project affords the U.S. Navy the ability transfer and store water on its

own behalf, thus creating the opportunity for resilience rather than just mere sustainability. This project is eligible for DCIP funding in future years based upon its FY2024 construction commencement.

Section 2861 modifies the DCIP Implementation Guidelines to more fully balance the resiliency needs of the installation to the quality of life needs of military personnel. Both are important aspects of any project; however, the amendments allow for consideration of more critical infrastructure projects than the current Implementation Guidelines. Such infrastructure is generally regional, serving both off-installation and on-installation needs, thus meeting the Congressional guidance of the scarcity and security assessments performed by the Department of Defense to determine scarcity, resiliency and encroachment at a particular installation.

Addressing scarcity and encroachment challenges at our military installation is critical to support their mission. The ability of the community surrounding the installation to help address such scarcity and resiliency issues is paramount to success. The DCIP provides one aspect to help these communities and the amendments to program proposed by Section 2861 place an emphasis on those priorities.

We appreciate this opportunity to express our support and, respectfully, urge you to adopt Section 2861 in the final FY2021 NDAA.

DISCUSSION

Staff received a brochure provided by WestWater Research (in your Board packet) containing information regarding a multi-year transfer opportunity for an entitlement of up to 3,300 acre-feet of State Water Project Table A water. Staff has reviewed the information provided and believes there is potential for this to provide a source to help meet the needs for an imported water supply. The timeline for communicating interest requires an Expression of Interest be submitted to WestWater Research no later than November 6, 2020. Staff has reached out to WestWater Research about the possibility of an extension to that date but has not received a response. Submitting an Expression of Interest is not a binding commitment, but the information provided enables robust follow-up discussions. A formal bidding process among priority buyers is anticipated thereafter in early 2021 unless a standout offer is identified beforehand. Formal negotiations and completion of definitive documents with the selected buyer are then planned for early to mid-2021.

RECOMMENDED BOARD ACTION(S)

Staff recommends Board support further consideration of the up to 3,300 acre-feet of water offered by Montecito Water District and direct staff to submit the necessary Expression of Interest by November 6, 2020.

RE: Expression of Interest in Multi-Year SWP Table A Transfer Opportunity

Dear Mr. Turner:

The purpose of this expression of interest ("XOI") is to set forth the general terms and conditions for a multi-year transfer ("Transfer") of State Water Project ("SWP") Table A water. [Buyer] is interested in entering into more detailed discussions with Montecito Water District ("Montecito") according to the general terms set forth in this XOI. Neither [Buyer] nor Montecito are bound in any way to proceed with the Transfer of the SWP Table A contemplated herein until final and completed documents are executed by the parties. Any such final and completed documents are subject to approval by Montecito's Board of Directors.

- 1. <u>Description</u>. [Buyer] seeks supplemental water to meet near-term and long-term water supply needs. Montecito has a Water Supply Agreement ("WSA") with the Central Coast Water Authority ("CCWA") entitling it to 3,300 acre-feet ("AF") of SWP Table A supplies. Due to an acquisition of desalinated water supplies from the City of Santa Barbara, Montecito's Table A supplies are anticipated to become increasingly surplus to Montecito's in-district needs. Montecito desires to facilitate a Transfer of its SWP Table A supplies that are annually surplus to its in-district demands ("Water") in order to offset the costs of acquiring desalinated water. [Buyer] proposes to purchase this Water. The quantity of Water to be made available for transfer on an annual basis will be at the sole discretion of Montecito.
- 2. Type of Transfer. This is a Transfer of SWP Table A from CCWA (on behalf of Montecito) to [Buyer]. The Transfer of the Water requires the approval of California Department of Water Resources ("DWR"), Montecito, CCWA, Santa Barbara County Flood Control & Water Conservation District ("SBCFCWCD"), [Buyer], and [any other approvals that may be needed].
- 3. <u>CEQA Compliance</u>. The transfer of SWP Table A is subject to the California Environmental Quality Act ("CEQA"). It is anticipated that [Buyer] will be the Lead Agency in the CEQA process and that [Buyer] will be responsible for preparing the required documents. The Transfer shall not proceed unless and until the parties negotiate, execute, and deliver mutually acceptable agreements based upon information produced

from the CEQA environmental review process and all governmental or other needed approvals. No party will be pre-committed to any approvals until all environmental work has been completed and all parties have made findings to proceed.

- 4. <u>Delivery of Water</u>. [Buyer] shall make all necessary arrangements with DWR for the conveyance of the Water to desired point(s) of delivery.
- 5. <u>Term.</u> The term of the agreement shall be for a period of [#] years ("Term"). It is anticipated that the Term will begin in [Start Year] and end in [Final Year].
- 6. Quantity. There is no defined quantity of Water during the Term. Depending on water supply conditions, some or all of Montecito's 3,300 AF of SWP Table A may be surplus to in-district needs and made available for transfer. [Buyer] is interested in acquiring all Water made available by Montecito. By May 15 of each year, Montecito shall determine the amount of Water available for transfer ("Quantity"). The annual Quantity to be made available during each year of the Term will be at Montecito's sole discretion. However, [Buyer] shall have a first right after Montecito's existing obligations to any Water Montecito transfers from its service area during the Term.
- 7. <u>Water Rate</u>. [Buyer] shall pay Montecito the following prices per AF ("Water Rate") based on SWP allocation:

a. 0% to 10% - $[Price 1] per AF;
b. 11% to 20% - $[Price 2] per AF;
c. 21% to 30% - $[Price 3] per AF;
d. 31% to 40% - $[Price 4] per AF;
e. 41% to 50% - $[Price 5] per AF;
f. 51% to 60% - $[Price 6] per AF;
g. 61% to 70% - $[Price 7] per AF;
h. 71% to 80% - $[Price 8] per AF;
i. 81% to 90% - $[Price 9] per AF; and
j. 91% to 100% - $[Price 10] per AF.
```

The Water Rate does not include a reimbursement by [Buyer] for SWP fixed costs incurred by Montecito as defined by the statement of charges from DWR and assessed to it by CCWA. Montecito's SWP fixed charges shall remain the obligation of Montecito through the Term.


8. <u>Delivery Costs</u>. [Buyer] shall assume all financial obligations for variable delivery costs incurred for the conveyance and delivery of Water.

- 9. <u>Payment</u>. On an annual basis, [Buyer] shall make a payment to Montecito equal to the Water Rate multiplied by the Quantity ("Payment") of Water delivered in the given year. The Payment shall be made on [Payment Date] of each year during the Term.
- 10. <u>Transaction Costs</u>. Each party shall be responsible for its legal, environmental and consulting costs. [Buyer] shall be responsible for preparing initial draft(s) of the definitive agreement(s). In the event that a third-party initiates a claim, [Buyer] shall defend the claim and hold harmless Montecito from any and all costs, fees and judgements resulting from the claim.
- 11. <u>Contingencies</u>. It is understood that the Transfer is contingent upon the following actions and activities:
 - a. Execution and implementation of amendments to the SWP Contracts providing for multi-year transfers of Table A water supplies;
 - b. Compliance with CEQA;
 - c. Approvals from and agreements with applicable regulating entities, including, but not limited to, DWR, CCWA, and SBCFCWCD;
 - d. Approval by [Buyer] of definitive agreements;
 - e. Approval by Montecito's Board of Directors of definitive agreements; and
 - f. [Any other contingencies buyer wishes to add]





Background: Montecito Water District

The District provides retail water supplies to nearly 11,400 customers in Santa Barbara County. Montecito maintains a broad water supply portfolio made up of local, imported, banked, and groundwater supplies. State Water Project (SWP) supplies are imported via the Coastal Branch and provided through a Water Supply Agreement with Central Coast Water Authority (CCWA), which manages the administration of SWP supplies associated with Santa Barbara (SB) County's SWP Contract. Montecito's Table A entitlement is 3,300 AF, including its 300 AF CCWA drought buffer.






